



FULFILLMENT & SHIPPING CHARGES

Dear Customer

We sincerely appreciate the opportunity to provide some or all of our fulfillment and drop shipping needs and ask that you carefully read the following terms and conditions required by Nutra Group LLC for this service.

Conditions for products to be drop shipped and / or fulfilled.

- All products to be drop shipped must be paid for in full by the customer.

Drop Shipping and Fulfillment Fees

- Drop Shipping fees are defined by a pick and pack charge and related shipping charges.
- (Example For shipping 1 Bottle) Pick and Pack Fees (\$2.54) + \$.50 Per Bottle + Shipping Fee (USPS \$2.04) = \$5.04

Nutra Group LLC does not guarantee a set shipping amount for all orders and this cost will be determined by the method of shipping specified by the customer. Nutra Group LLC will discuss the various shipping options with the customer so that the best means is determined and agreed by the both parties.

Method Of Shipping

- Orders will be shipped by UPS or USPS.

Lost Or Damaged Shipments

- Nutra Group LLC agrees to ship by the method and to the address(s) specified by the Customer and Nutra Group agrees to be responsible for any loss or damage resulting by the failure of Nutra Group LLC to follow these specifications.
- While Nutra Group LLC will assist the Customer in tracing and filing claims for any lost or damaged orders through no fault of Nutra Group LLC, the Customer agrees to accept responsibility for any loss or damaged resulting from an error on the behalf of the Customer or the failure of UPS or USPS to properly deliver the order.

Fulfillment & Drop Shipping Deposits

- A deposit must be made towards the Drop Shipping and Fulfillment fees based on the projected volume and will be applied against orders as they are shipped. The Customer will be notified by email when the deposit is diminished to a predetermined amount at which time the customer will have the option to replenish the deposit required. The deposit may have to be adjusted as the Customer's volume changes, up or down, as the agreed to by the Customer and Nutra Group LLC.

Termination Of Services

- The Customer and NutraGroup LLC may terminate the Drop Shipping & Fulfillment service at any time, but the Customer agrees to pay for any outstanding Drop Shipping Fees owed to Nutra Group LLC.
- The Customer's Drop Shipping deposit will be refunded immediately to the Customer by Nutra Group LLC up the Customer's termination of the Drop Shipping & Fulfillment services by Nutra Group LLC provided there are no outstanding Drop Shipping Fees owed by the Customer. In the event that outstanding fees exist, the Customer agrees that remaining deposit may be applied to these fees and that any amount in excess of the deposit will be paid immediately by the customer.
- Upon termination of services by either party, all remaining inventory belonging to the Customer will be made available to the Customer by Nutra Group LLC provided that all of the other conditions of this agreement have been met by the Customer.
- Standard terms for shipping charges apply.
